## PANASONIC GENERAL TERMS AND CONDITIONS OF PROMOTION

These promotion general terms and conditions apply only to this specific promotion. In addition, all instructions, rules and conditions relating to this specific promotion form part of these general promotion terms and conditions. Panasonic reserves the right to change the terms and conditions of its promotions at its discretion.

### Promotion

The promotion is only valid for Panasonic PBX products and for a qualifying period from April 1st 2010 to 30th June 2010. We will consider the turnover of all Panasonic PBX product purchased during this period. We consider the net turnover – taking account of returned products.

The promotional offer will provide a T780 Panaboard (UB-T780) for each €6000 of Panasonic PBX products. The reseller has to claim their Panaboard before 15<sup>th</sup> July 2010 (15 days after the promotion finishes. After that date, the reseller is not entitled to receive any other product or compensation.

- Panasonic reserves the right to demand proof of the purchase (invoices) at its discretion.
- This promotion cannot be used in conjunction with any other Panasonic promotion.
- Panasonic reserves the right to replace the product at its discretion (with a similar one – the dealer/reseller will be notified) as a result of to availability, discontinuation, etc.
- The dealer/ reseller can not demand any compensation if lack of stock of Panasonic PBX products prevents sale completion. The promotion will be settled based in real turnover at the end of the promotion (30<sup>th</sup> June2010) without taking account of pending orders or orders not delivered before that date.

### Procedure of the promotion

- The dealer/ reseller purchases Panasonic PBX Products during the period
- After the promotion has ended the dealer/ reseller must send to Panasonic the settlement document requesting the Panasonic Panaboard. The document must be received before 15<sup>th</sup> of July 2010 together with proof of the purchases (invoices).
- Panasonic will check all the information and send directly to the dealer/reseller.
- The Panaboard installation and programming is not included and assumed to be managed by the purchasing dealer.
- It's necessary a PC and a projector in order to use the Interactive Panaboard. Both components and other accessories (except the Panaboard) are not included in the promotion.

### Cancellation, return and compensation for the promotion

In respect of the promotion:
